The Project consists of **rehabilitation work on existing components of the WWTP including:**

Clarifiers- Rehabilitation and Cleaning of 2 clarifiers. Concrete and steel structures of the existing clarifiers are still serviceable and be reused after reconditioning. All other Components Rehabbed. Baffles and Trough replaced.

Return Activated Sludge (RAS) Pumps- 2 RAS Pumps will be rebuilt as part of this project.
